ORDER

The Principal, MET'S School of Engineering, Kuruvilassery (P.O), Mala, Thrissur applied for (1) B.Tech Civil Engineering and (2) B.Tech Applied Electronics and Instrumentation Engineering programmes with an intake of 60 students each, vide paper read as first.

The District Level Inspection Commission recommended for B.Tech Civil Engineering programme alone with an intake of 60 students.

The All India Council for Technical Education has conveyed its approval to B.Tech Civil Engineering programme for the year 2012-13 vide letter read as third.

The Higher Education Department, Government of Kerala granted Administrative Sanction to B.Tech Civil Engineering course in MET'S School of Engineering, Mala, Thrissur during the academic year 2012-2013 vide G.O read as fourth.

On signing an agreement with the Government a No Objection Certificate was issued vide G.O read as fifth.

The Principal and the Chairman of the college have jointly submitted an undertaking to the effect that they would faithfully carryout the provisions of University Act, Statutes, Ordinance, Regulations and directions of the University.

The Administration and affiliation fee for the programme for the academic year 2012-2013 was already remitted as per chalan No.1 dated 29.06.2012 alongwith application for Continuation of Provisional Affiliation to other programmes.

Provisional affiliation is therefore granted for starting B.Tech Civil Engineering programme in MET'S School of Engineering, Kuruvilassery, Mala with an intake of 60 students during the academic year 2012-2013 subject to ratification by the Senate.

Affiliation granted is strictly provisional and only for the academic year 2012-13. The College has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.

Selection and admission shall be made only on the basis of the rules and regulations of the University and Government, and on the basis of the directions issued from time to time, failing which the affiliation granted shall automatically be cancelled.

The Institution shall take appropriate measures for prevention of ragging in any form, in the light of the direction of the Supreme Court of India in Writ Petition (C) 656/1998. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation will be initiated.

Orders are issued accordingly.
