ORDER

Provisional affiliation was granted for starting B.Tech degree courses in MET's School of Engineering (Unaided), Kuruvilassery, Mala, Thrissur during the academic year 2002-2003 with the following courses, vide University Order read as first.

1. Biotechnology - 60 students.
2. Electronics and Communication Engineering - 60 students
3. Computer Science Engineering - 60 students.

Additional affiliation was granted to B.Tech in Electrical and Electronics Engineering during the academic year 2004-2005 in the college with an intake of 60 students vide University Order read as second.

Additional affiliation was also granted for starting B.Tech in. (1) Mechanical Engineering (2) Electronics and Communication Engineering (3) Computer Science Engineering with an intake of 60 students each, (ie. Intake enhanced from 60 to 120 each) during the academic year 2009-2010 vide University Order read as third.

Provisional Affiliation was granted for starting B.Tech Civil Engineering with an intake of 60 students during the academic year 2012-13 subject to ratification by the syndicate vide University Order read as 4th.

Provisional affiliation was granted for starting M.Tech VLSI Design and M.Tech Bio Process Engineering with an intake of 18 students each during the academic year 2011-2012 vide University Order read as 5th and 6th respectively.

Continuation of Provisional Affiliation was granted to the courses (except Civil Engineering & M.Tech courses) upto the academic year 2012-2013 vide University Order read as 7th.

The Principal, MET's School of Engineering, Kuruvilassery (PO), Mala, Thrissur District, vide letter read as 8th, has requested to grant Continuation of Provisional Affiliation to the B.Tech and M. Tech courses for the academic year 2013-2014. An amount of Rs.4,90,000/- (Four lakhs and Ninety thousand only) was remitted towards administration and affiliation fee vide chalan No.1 dated 24-04-2013 at SBT, Kuzhur branch.

The All India Council for Technical Education, as per the letter read as 9th, has extended its approval to the B.Tech & M.Tech courses for the year 2013-2014.

Among the courses to which Continuation of Provisional Affiliation is sought, an Inspection commission has to be appointed in respect of B.Tech Civil Engineering since it was started during 2012-2013. In the case of M.Tech VLSI Design and M.Tech Bio Process Engineering Inspection commission has been appointed vide University Order read as 10th. But in view of the time schedule fixed by the Commissioner for Entrance Examinations based on the judgment of the Supreme Court of India, the Continuation of Provisional Affiliation is granted to the B.Tech and M.Tech courses for the academic year 2013-2014 and later it shall be followed by Inspection and other procedures if any.

Continuation of Provisional Affiliation, is therefore, granted to the B.Tech & M.Tech courses for the academic year 2013-2014 in MET's School of Engineering, Kuruvilassery (PO), Mala, Thrissur as detailed below.

Affiliation granted is strictly provisional and only for the academic year 2013-2014. The College has to apply for Continuation of Provisional Affiliation for the ensuing years., remitting the fee fixed by the University, along with a copy of letter extension of approval from the apex bodies concerned.

Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C)656/1998 the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.


Admission to the next academic year shall be made only after obtaining prior permission from the University.
